**PREAMBLE**



The Extension of time limit of Electronics & IT/ITeS Start-up Policy (2016-21) and Scheme of assistance for incubators and Start-ups under Electronics & IT/ITeS Start-up Policy (2016-21) came to an end on 05<sup>th</sup> December, 2021. Formulation of New Electronics & IT/ITeS Start-up Policy and Scheme of assistance for Incubators and Start-ups under Electronics & IT/ITeS Start-up Policy is under process. The matter of extension of mentioned Policy and Scheme was under consideration of the Government.

**RESOLUTION**
