The State Government has announced "Electronics & IT/ITeS Start-up Policy for the State of Gujarat (2016-21)" together with the "Scheme of assistance for Incubators and Start-ups under Electronics & IT/ITeS Start-up Policy for the State of Gujarat (2016-21)" vide Government resolutions dated 06th June, 2016 read above. The Extension of time limit of Electronics & IT/ITeS Start-up Policy (2016-21) and Scheme of assistance for Incubators and Start-ups under Electronics & IT/ITeS Start-up Policy (2016-21) came to an end on 04th June, 2022. Formulation of New Electronics & IT/ITeS Start-up Policy is under process. The matter of extension of mentioned Policy and Scheme was under consideration of the Government.
