PREAMBLE:

- 1. Under the "Digital India Mission" envisaged by Gol, one important pillar is creation of broadband highways connecting all the villages.
- 2. BSNL is implementing and maintaining the network of BharatNet Phase-I project in Gujarat and has requested for providing network connectivity over BharatNet Phase-I network to Government Offices/Institutions under various departments like Government Schools, Government Health Centers, etc
- 3. The matter for deciding recurring charges per month per location for providing the Connectivity of 100 MBPS to various Government Offices from Gram Panchayats under BharatNet Project Phase-I and the matter of One Time Commissioning (OTC) charges for connecting Government Offices were under consideration of the State Government.

RESOLUTION:

After careful consideration, the State Government has decided to fix **recurring charges of** Rs 1000/- **per month per location** for providing the Connectivity of 100 MBPS to various Government Offices/institutions from Gram Panchayat under BharatNet Project Phase-I with **One Time Commissioning (OTC) charges** for providing the connection which will be paid as per actuals by respective Government Offices. These recurring charges will be valid upto 31st March 2023, and will be reviewed thereafter.

- 2. For operationalization of the broadband services BSNL, Gujarat will develop an application/software for
 - Online Process for new connection request
 - Online Billing Process
 - User should have rights to view month wise utilization of Bandwidth / Data for their respective
 offices.

- Complain Management System (inclusive of Bandwidth Issue, Network Issue, Government Services related issue, etc...)
- Help Desk and Monitoring System along with Help-line number
- 3. For payment modalities, BSNL will establish necessary arrangements between respective Government Offices and BSNL and to inform the same to Department of Science and Technology (DST) and other Administrative Departments.
