The Gujarat Government has setup an SPV namely "Gujarat Fibre Grid Network Limited (GFGNL)" to implement Phase-II of Bharat Net Project in Gujarat. It was established in 2016 and It is registered under the Companies Act, 2013 This SPV has been created to synergize with the efforts of Government of India under the National Optical Fibre Network and Digital India initiative and make focused efforts to actualize a state-to-village fibre grid and to facilitate building common Government owned infrastructure to provide internet facilities to residents of State of Gujarat.

Taking into consideration the complex needs in this direction, the Gujrat fibre Grid Network Limited (hereinafter referred as GFGNL) is looking for empanelment of competent & experienced Advocates & Law firms at its administrative office at Ahmedabad/ Gandhinagar. The services of Advocates/Law firms will be mainly utilized in the matters/litigation work being contemplated at various forums i.e. Hon'ble Supreme Court of India, Hon'ble High Court of Gujarat, District Courts, Industrial Tribunals, National Consumer Disputes Redressal Commission, State Consumer Commission, District Consumer Forum and various Commissions & Other Quasi-judicial bodies in matters relating to contract made with vendors and contractual employees, Arbitration matter, RTI matter at SIC, etc., within Gujarat as well as outside Gujarat region.

The practicing advocates who are registered with Bar Council of India/State Bar Council are eligible for empanelment. The qualification, experience, fees, other terms and condition and the application format in which the application has to be made, have been attached.

Application for empanelment at GFGNL does not confer any right/assurance whatsoever, to an applicant that he/she will be empaneled on the panel of GFGNL. Letters to advocates confirming their empanelment will be issued by GFGNL separately

1. <u>The GFGNL invites "Expression of Interest Applications" from interested Advocates/Law Firms for the Scope of Work (SoW) which inter-alia includes the following:-</u>

- ➤ Rendering legal services and providing opinion, as and when referred, on matters related to contract made with vendors and contractual employees, Arbitration matter, RTI matter at SIC and Disciplinary proceedings, GST/Income tax/Labour cess/EPF matter, Labour, Company & Industrial Law matter etc. besides other litigation matters.
- ➤ Handling notices and other legal queries, as and when referred.
- ➤ Representing the GFGNL before any Court of Law or Tribunal or Statutory Body or Quasi-judicial authority or Arbitrators/Arbitral Tribunals under the relevant act(s) and any other proceedings, as and when referred.
- ➤ Conducting legal due diligence, as and when referred.
- ➤ Providing legal opinion, advice related to Legal matters of the GFGNL as and when referred.
- ➤ Legal Vetting of draft notices, agreements, bidding documents, MoAs, MoUs etc.

## 3. Essential Eligibility Criteria

- ➤ The responding Advocates & Law Firms should be registered under the Statutes of India.
- > They should be having office at Ahmedabad/Gandhinagar.
- Advocates/Law Firms should possess minimum experience of Seven/Ten years respectively in representing PSU/Autonomous Bodies/ Govt. Departments on Contractual Disputes.
- ➤ Advocates/Law Firms must have the requisite infrastructure and inhouse capability.
- Advocates/Law Firms should possess professional expertise especially in handling cases in the areas stated above.
- Advocates/Law Firms should not have been debarred by any Central/State Government/Government Departments/SPV.

## 4. Expected expertise/inputs

- Understanding of the scope of work;
- ➤ Domain specific experience in each of the areas relevant to SoW; and Adequate in-house capacity to meet the SoW

## 5. Expected Deliverables

Timely opinions on the referred issues; and Prompt legal services

## 6. Correspondence with Applicant

Given and except as provided in EoI, the GFGNL shall not entertain any correspondence with any applicant in relation to the acceptance or rejection of any application. GFGNL, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time to:

- ➤ Suspend and/or cancel the EOI process and/or amend and/or supplement the EOI process or modify the dates or other terms &conditions relating there-to.
- ➤ Consult any applicant in order to receive clarification or further information.
- > Empanel or not to empanel any applicant.
- ➤ Retain any information and/or evidence submitted to the GFGNL, on behalf of, and/or in relation to any applicant and/or.
- ➤ Independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any applicant.

#### 7. Fee Schedule:

- > The schedule of fee payable for services rendered, shall be applicable as decided by the GFGNL from time to time.
- ➤ No retainer fee shall be paid to any panel Advocate merely because such advocate has been empaneled

#### 7. PROCEDURE FOR EMPANELMENT:-

- ➤ The applications received will be evaluated & the Advocates/Law Firms will be empaneled on the basis of their expertise and experience in litigation.
- ➤ The applicant advocate/Law Firm must apply in the format prescribed by the GFGNL only. No other format will be entertained.
- ➤ Any application received after the last date prescribed in the advertisement shall not be entertained.
- ➤ No applicant advocate shall be called for interview/interaction unless he/she satisfies the eligibility conditions and is shortlisted for the

same.

- ➤ Depending upon the requirement and number of applications received, GFGNL reserves the right to shortlist the candidates to be called for interview/interaction and to be empaneled. Merely fulfilling the eligibility criteria will not confer any right on an applicant advocate to be called for interview/interaction and to be selected.
- ➤ The decision of the competent authority regarding short listing and selection of the candidates shall be final.
- ➤ Canvassing in any form shall be treated as a disqualification. The candidature of such applicants shall be cancelled forthwith. The applicant advocate shall bring original documents at the time of interview.
- ➤ Letter to the applicant advocates confirming their empanelment will be issued by GFGNL separately.
- ➤ The Advocates/Law Firms shall be solely responsible for the correctness of the details provided in their applications. In case of any misrepresentations noticed at any time, the Advocate/Law Firm shall be removed from the list of empanelment and the cases in hand will be withdrawn and the advocate/firm shall be debarred from entrustment of any work of GFGNL.
- ➤ GFGNL reserves the right to allot matters/cases to the advocates/law Firms from the empaneled list or outside the list, in its sole discretion.

## 8. <u>DUTIES OF THE EMPANELLED ADVOCATES/LAW FIRMS:</u>

- ➤ The Advocate/Law Firm shall not advise any party or accept any case against the GFGNL in which he/she has appeared or is likely to be called upon to appear for or advise which is likely to affect or lead to litigation against the GFGNL.
- ➤ Timely appearance of the Counsel to contest the cases for GFGNL in the court is a must. His/her absence in the Court, without any reasonable ground and notice in advance, will not be accepted.
- ➤ GFGNL sends the information to the panel advocates through email regarding entrustment of a case and after receiving the e-mail, it is duty of the panel Advocates to collect the brief/copy of petition along with assignment letter from the concerned office of GFGNL at the earliest.
- ➤ GFGNL is free to engage any advocate of its own choice and an empaneled Advocate shall make no claim that he/she alone should be entrusted with GFGNL's legal matter(s).
- ➤ Refusal by any advocate/Law Firm to accept any work without any reasonable cause (e.g. on grounds of conflict of interest) may entail removal of such advocate from the panel, forthwith without waiting for the empanelment period to expire.
- > The advocates/Law Firms shall accept the terms and conditions of the

- empanelment as determined by the GFGNL from time to time.
- ➤ In order to ensure that there is effective check on the cases being conducted, the Advocates/Law Firms on the panel must report the status of the cases after each date of hearing. Failure to submit status report will be a ground for removal of the name from the panel.
- ➤ In cases where on the request of the Department of Science and Technology, GOG have also to be represented, no extra fee shall be paid to the advocate. i. If required render all assistance to special or senior Counsel engaged in a particular case before the High Court and other judicial bodies.
- ➤ To Keep GFGNL informed and updated on all-important developments in the designated cases, dates of hearing, order of the court on the date of its pronouncement, supplying copy of orders /judgment etc.
- Furnish statement about the cases represented by him/her before the concerned courts or any other authority and their outcomes.
- ➤ When any case attended by him/her is decided against the Organization, the Advocate/Law firm concerned must give considered opinion regarding the reasons for such adverse order and the advisability of filing an appeal from such a decision not later than 5 working days of the order (kuchha copy). 30% of the fees payable to the counsel shall be deducted if the certified copy of the judgment is not handed over to the concerned section of GFGNL within five days (excluding the time taken by the court in preparation of the copy) from the date of judgment

#### 9. REMOVAL FROM PANEL

- ➤ GFGNL reserves the right to terminate the empanelment of a Advocate/Law Firm with one month's notice in writing without assigning any reason. The Advocate/Law Firm may also withdraw his services from the Organization by serving one month's notice.
- ➤ Empanelment shall be liable to be cancelled due to occurring of any of the following disablements on the part of the Advocate/Law firm

A Giving false information in the application for empanelment;

- B. Failing to attend the hearing of the case without any sufficient reason and/are prior information;
- C. Not acting as per GFGNL's instructions or going against specific instructions;
- D. Threatening, intimidating or abusing any of the GFGNL's Employees, officers, or representatives;
- E. Passing on information relating to GFGNL's case on to the opposite parties or their advocates or any third party which is likely to cost any damage to the GFGNL's interests;
- F. Giving false or misleading information to the GFGNL relating to the proceedings of the case;
- G. Seeking frequent adjournments or not objecting the adjournment moved by other party without sufficient reason;
- H. Frequent absence from the Court proceeding even if "pass over" or "proxy" is obtained by an advocate

## 10.Validity of Empanelment:

The empanelment shall be valid for two years. Performance of empaneled advocates/law firms shall be reviewed at regular intervals for continuance in the panel of Advocate. However, GFGNL reserves the right to modify the validity period at its sole discretion, without assigning any reasons.
