Preamble:

The State Government has declared BISAG, Gandhinagar as BISAG(N) with effect from 1st June, 2020 and transferred the management, administration and control along with its all assets and liabilities to Ministry of Electronics and IT (MeitY), Government of India vide GR referred at Sr. No. (2). However, the approval of the Governing Body of BISAG was awaited to transfer assets and liabilities of BISAG to MeitY, Government of India along with its details. The Governing Body of BISAG has now resolved to transfer the same in its XXIVth meeting vide minutes referred at Sr. No. (3). BISAG has provided the details of its assets and liabilities to be transferred to MeitY, Government of India vide its letter referred at Sr. No. (4) above.

Resolution:

In view of above details and after careful consideration, the State Government is pleased to transfer all assets and liabilities of BISAG to Ministry of Electronics and IT (MeitY), Government of India as per the Annexure I to VIII attached to this resolution.
