**No. GST/01/2016/DIT/10/2015/ASSTDIR/IT:-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-governance, Gujarat State, namely:-

1. These rules may be called the Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-governance Recruitment Rules, 2016.
2. Appointment to the post of Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-governance, Gujarat State, shall be made either-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who-
    - (i) have worked for not less than eight years in the cadre of Information and Communication Technology Officer, Class II, under the Directorate of Information and Communication Technology and e-governance, Gujarat State, and

- (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

Provided further that the Government may appoint a person who possesses the educational qualification and experience as specified in rule 4(b) against the promotion quota on contract basis for not exceeding one year in consultation with Gujarat Public Service Commission; or

- (b) by direct selection; or
- (c) by temporary transfer on deputation basis from amongst the persons working in Central Government or State Government or Government undertaking Board or Corporation and who possess the educational qualification and experience as specified in rule 4 till the candidates not available for the post.

3. The appointments by promotion and by direct selection under the sub rule (a) and (b) of rule 2 shall be made in the ratio of 1:2 respectively.



4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, –

- (a) not be more than 40 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;


- (b) possess –

a degree of Bachelor of Engineering or Bachelor of Technology in Information Technology or Computer Science or Computer Engineering or Electronics or Electronics and Communication or Computer Technology or a degree of Master of Computer Application or Master of Science (IT) obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and

- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
- (d) have about five years cumulative experience in the field of Computer Technology or Communication Technology or Information Technology in any organization of Government or Local Bodies or in a Company whose annual turnover of ₹ 30 crores or above and which is established under the Companies Act, 2013; and
- (e) possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be on probation for a period of two years.
5. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-Service Training and Examination Rules, 1970.
6. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
8. The candidate appointed by direct selection shall require to pass the examination as may be prescribed by the Government.
9. The candidate appointed by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.

**No. GST/03/2023/DIT/10/2015/ASSTDIR/IT: -** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-Governance Recruitment Rules, 2016, namely: -

1. (1) These rules may be called the Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-Governance Recruitment (Amendment) Rules, 2023.  
  
(2) They shall come into force from the date of their publication in the *Official Gazette*.
2. In the Assistant Director of IT, Class I, in the General State Services, under the Directorate of Information and Communication Technology and e-Governance Recruitment Rules, 2016 (hereinafter referred to as “the said rules”), in rule 2, in sub-rule (a), for the words “by promotion of a person of proved merit and efficiency”, the words, brackets and figures “by promotion of a person who possesses “Good” benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967” shall be substituted.

3. In the said rules, in rule 4,-

- (i) in sub-rule (a), for the figures and word "40 years", the figures and word "42 years" shall be substituted;
- (ii) in sub-rule (a), after the existing proviso, the following proviso shall be inserted, namely:-

"Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.";

- (iii) in sub-rule (b), after the words "Computer Technology or", the words "Information and Communication Technology or", shall be inserted;
- (iv) sub-rule (c), shall be deleted;
- (v) for sub-rule (d), the following sub-rule shall be substituted, namely:-

“(d) have about five years combined or separate experience, excluding teaching experience, in the field of Computer Technology or Communication Technology or Information Technology or Information and Communication Technology in,-

- (i) Any organization of Government, or
- (ii) Any Municipal Corporation, or



(iii) Any Organization of Government Undertaking Boards, or

(iv) Any Organization of Government Undertaking Corporations, or

(v) Any Company is established under the Companies Act, 1956 or the Companies Act 2013, and out of which half the experience has been in a company or companies which is CMM (Capability Maturity Model) Apprised or is ISO certified or listed in any of the stock exchanges in the world or which is a member of NASSCOM (National Association of Software and Service Companies) or member of Electronics Industries Association of India (ELCINA) or member of India Cellular and Electronics Association (ICEA) or member of India Electronics and Semiconductor Association (IESA) or having paid up capital of at least Rs.1.00 Crore, or

(vi) Combination of above experiences:

Provided that if part of the experience comes from companies, then minimum half of such companies experience shall be from companies which are CMM (Capability Maturity Model) Apprised or ISO certified or listed in any of the stock exchanges in the world or which is a member of NASSCOM (National Association of Software and Service Companies) or member of Electronics Industries Association of India (ELCINA) or member of India Cellular and Electronics Association (ICEA) or member of India Electronics and



Semiconductor Association (IESA) or having paid up capital of at least Rs.1.00 Crore.”.

4. In the said rules, before the existing rule 5, for the figure and words, “4. The candidate appointed by direct selection shall be on probation for a period of two years.”, the figure, letter and words “4A. The candidate appointed by direct selection shall be on probation for a period of two years.” shall be substituted.
5. In the said rules, rule 6 shall be deleted.
